Cancellation policy & withdrawal form

A. Cancellation policy

Introduction

Consumers shall have the right of withdrawal subject to the following conditions, whereby consumers are any natural person who enters into a transaction for purposes which, for the most part, cannot be attributed to their commercial or self-employed professional activities:

right of withdrawal

You have the right to withdraw from this contract within fourteen days without giving reasons.

The withdrawal period shall be fourteen days from the date on which you or a third party named by you, other than the carrier, have taken possession of the last goods.

In order to exercise your right of withdrawal, you must contact us (Simon Breunig, alte Hochkulturen, Adam-Zöller-Str. 5, 63906 Erlenbach, Germany, tel.: 0151-12408130, e-mail: altehochkulturen@mail.de) by means of a clear declaration (e.g. a letter sent by post or e-mail) about your decision to withdraw from this contract. They may use the attached model withdrawal form, but this is not required.

In order to safeguard the withdrawal period, it is sufficient that you send the notice of the exercise of the right of withdrawal before the expiry of the withdrawal period.

Consequences of revocation

If you withdraw from this contract, we will have to refund to you all payments we have received from you, including delivery costs (except for additional costs resulting from the fact that you have chosen a different type of delivery than the cheapest standard delivery offered by us), without delay and at the latest within fourteen days of the date on which we received the notification of your withdrawal of this contract. We will use the same means of payment for this repayment that you used in the original transaction, unless otherwise expressly agreed with you; in no case will you be charged for this repayment. We may refuse to refund until we have received the goods back or until you have provided proof that you have returned the goods, whichever is the earlier.

You shall return or transfer the goods to us immediately and in any event no later than fourteen days from the date on which you inform us of the revocation of this contract. The deadline is met if you send the goods before the fourteen-day deadline.

They shall bear the direct costs of returning the goods.

They shall only be liable for any loss of value of the goods if that loss of value is due to a handling of the goods which is not necessary for the examination of the nature, characteristics and functioning of the goods.

Exclusion or early cancellation of the right of withdrawal

The right of withdrawal shall not apply to consumers who are not members of a Member State of the European Union at the time of the conclusion of the contract and whose sole residence and delivery address are outside the European Union at the time of the conclusion of the contract.
